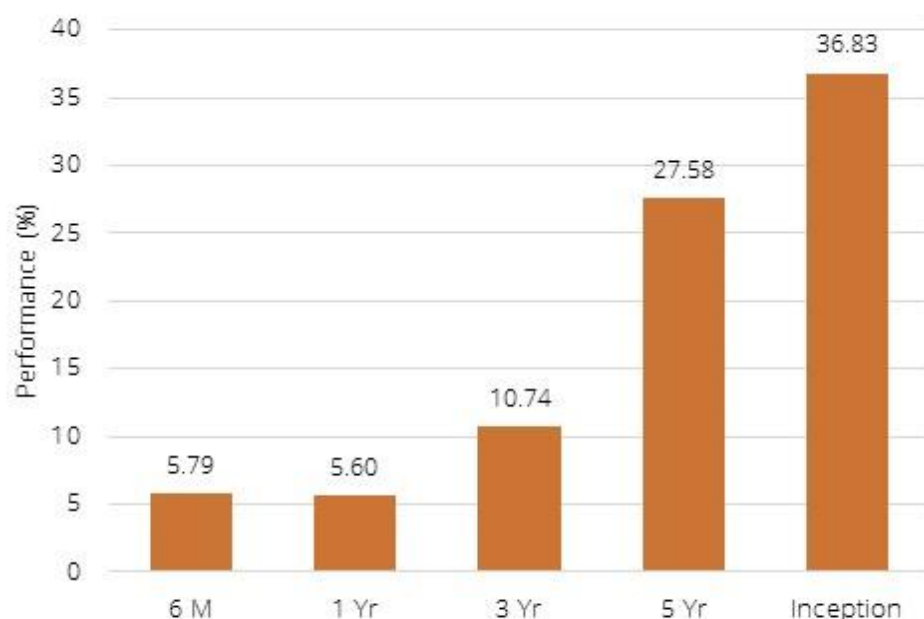

About the Hardy Managed Portfolios

The investment objective is to grow the capital value of the portfolio whilst providing an income. The strategy is ESG integrated and considers Environmental, Social and Governance factors alongside traditional financial metrics. The Casterbridge Wealth 4 Income Strategy may be suitable for an investor with a time horizon of more than 5 years, and a low-medium tolerance for risk.

The Casterbridge Wealth 4 Income Strategy is a diversified portfolio, the largest asset allocation being to domestic and international equities as well as fixed interest. There is an allocation to "alternative investments" such as commercial property, private equity, commodities and absolute return strategies.

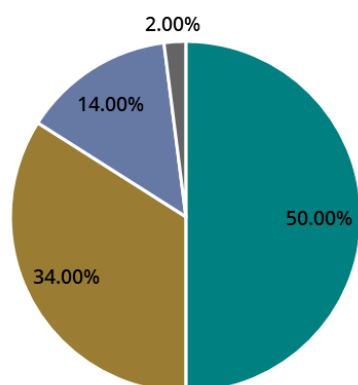
